### Efforts of the General Assembly to Pass a Budget

Over the past two weeks, the Governor has had an opportunity to protect State workers' pay by enacting a budget to cover payroll for FY 17. The proposal introduced by Rep. Sue Scherer would fund the cost of State workers' pay. However, in a message to State workers, the Governor made it clear he will veto that bill. Instead, he prefers to enact a bill filed by Rep. Avery Bourne that would give him unlimited, permanent spending authority and give his Office of Management and Budget total oversight of the salaries of other constitutional officers' employees.

HB 1798	Appropriates line items for the costs of State workers' pay
HB 2803	(1) Gives the Governor unlimited, permanent spending authority for State workers' pay, and (2) requires the Governor's Office of Management and Budget to approve State workers' pay for other constitutional officers

#### Article VIII, Section 2 of the Illinois Constitution provides:

"The Governor shall prepare and submit to the General Assembly, at a time prescribed by law, a State budget for the ensuing fiscal year."

Since taking office in 2015, the Governor has deliberately snubbed his constitutional duty to present a balanced State budget, choosing instead to create an economic and political crisis intended to collapse Illinois government. Despite the Governor's unwillingness to introduce a budget or work with the General Assembly to approve a budget, the Democratic majority of the Illinois General Assembly has tried on numerous occasions to enact a budget. Since July 2015, the General Assembly has passed 28 budget bills, of which only 6 were signed by the Governor and the remainder were vetoed. If the Governor wanted to avoid operating without a budget and continue to pay State employees, he could have used his constitutional authority to reduce a line item or veto a line item, while allowing the remainder of those budget bills to become law.
